Revision of Pay scales in Government and Grant-in-aid Diploma level Engineering/ Pharmacy Institutions as per AICTE Recommendations

Preamble:

The Government of India and All India Council for Technical Education (AICTE) have decided to implement the scheme of revision of pay scales of Teachers in Diploma level Engineering/Pharmacy colleges with effect from 01.01.2006 vide its letter dated 5.3.2010 cited above. The question of revision of pay scales of employees of government and grant-in-aid Diploma level Engineering/Pharmacy colleges on the lines of government of India was under consideration of Gov rnment of Gujarat

RESOLUTION:

Government has considered the issue mentioned in preamble carefully and it has been decided that the pay scales of employees of Government and Grant-in-aid colleges offering Diploma courses in Engineering/Pharmacy be revised as per cadres and pay scales shown in Annexure-I with effect from 1.1.2006.


The other terms and conditions of revision of pay scales of various cadres are mentioned in Annexure-II. The fixation of the pay shall be done as per the fitment tables in Annexure-III as prescribed by Government of India, Ministry of Human Resource Development, Department of Higher Education Letter No. F-3-1/2009-U.I dated 04/06/2009.

The list of Institutes and posts covered under this pay revision is mentioned in Annexure-IV.

The revision of pay is subject to fulfillment of conditions prescribed in AICTE notification date 05/03/2010.

Other terms and conditions prescribed by finance department shall be as under:

- 1. The benefits of pay revision shall be applicable to cadres 1 to 6 mentioned in annexure-I. This pay revision will be subject to fulfillment of conditions and educational qualification prescribed in AICTE notification dated 05/03/2010.
- 2. The benefits of revision of these pay scales shall not be applicable to teachers appointed on fixed pay and contractual posts.
- 3. All the resolutions issued by Government of Gujarat in respect of AICTE shall be strictly observed by Government /GIA institutions. Any exemption shall not be permitted without prior approval of the State Government.
- 4. Additional posts shall not be created and benefit of AICTE pay scale shall not be given to such posts without prior approval of the State Government.
- 5. The benefits of revision of these pay scales shall not be applicable to the posts other then those mentioned in Annexure-I. If the institutions exercise its own authority in this regard, the responsibility of Director of Technical Education shall have to be fixed.
- 6. All the colleges shall strictly observe service matter rules.
- 7. Additional posts shall not be created by Government and Grant-in-aid institutions and no recruitment shall be made on their own.
- 8. For creation of new posts and recruitment on posts there of, prior approval of State Government shall have to be obtained. In case of failure to observe this condition, the responsibility of Joint Director/ office of the Directorate of Technical Education shall be fixed.
- 9. Economy policy of the State Government shall have to be strictly observed.
- 10. Arrears to those employees, who have GPF accounts, shall be deposited in their GPF accounts in five equal installments from the financial year 2009-10. Arrears to those employees, who have CPF accounts, shall be paid in cash in five equal installments from the financial year 2009-10.



- 11. Additional Allowances shall not be sanctioned or paid other than sanctioned in fifth pay scale. Prevailing Allowances shall not be increased.
- 12. The pay fixation for Diploma Level Technical Institutions shall be done by IFMS system only.
- 13. If any post is filled up/will be filled up by Government/GIA institutions without approval of the State Government, such post shall not be entitled for benefits of pay revision and pension / retirement.
- 14. Retirement age of the Polytechnic employees shall be kept as it is i.e.58 years.
- 15. All the conditions like educational qualifications / experience etc. prescribed by AICTE dated 05/03/2010 respectively shall be completely observed and in case of failure to observe such condition, the sanctioning authority shall be personally held responsible.





1. Revised Pay Scales, Service conditions and Career Advancement Scheme for teachers and equivalent positions:

The pay structure for different categories of teachers and equivalent positions shall be as prescribed in All Indian Council for Technical Education Notification F-No·37-3/Legal/2010 dated 05-03-2010.

[A] Lecturer in Polytechnics:-

- (1) Persons with B.E. / B.Tech. Qualification in appropriate branch / discipline either entering the teaching profession newly or lecturer already in service in polytechnic institutions shall be designated as Lecturer and shall be placed in the Pay Band of Rs.15600-39100 with AGP of Rs.5400 and will move to AGP of Rs.6000 on completion of Masters in qualification in appropriate branch / discipline.
- (2) Persons with M.Tech. / M.E. qualification in an appropriate branch / discipline either entering the teaching profession newly or lecturer already in service in polytechnic institutions shall be designated as Lecturer and shall be placed in the Pay Band of Rs.15600-39100 with AGP of Rs.6000.
- (3) A Lecturer with completed service of 4 years, possessing Ph.D. degree in the relevant branch / discipline shall be eligible, for moving up to AGP of Rs.7000.
- (4) A Lecturer possessing Masters' degree in the relevant branch / discipline as defined for technical education shall be eligible for the ΛGP of Rs.7000 after completion of 5 years service as Lecturer.
- (5) Lecturers who do not have Ph.D or a Master's degree in the relevant branch / discipline of a program shall be eligible for the AGP of Rs.6000 only after completion of 6 years serv ce as a Lecturer.
- (6) Lecturers who do not have Ph.D or a Master's degree in the relevant branch / discipline of a program shall be eligible for the AGP of Rs.7000 only after completion of 9 years service as a Lecturer.
- (7) The upward movement from AGP of Rs.5400 to AGP of Rs.6000 and from AGP of Rs.6000 to Rs.7000 for all Lecturers shall be subject to their satisfying other conditions as laid down by AICTE.



- (8) The pay of the incumbents to the posts of Lecturer (Senior scale) (i.e. the prerevised scale of Rs.10000-15200) shall be fixed at the appropriate stage in Pay Band of Rs.15600-39100 based on their present pay, with AGP of Rs.7000
- (9) Lecturers with completed service of 5 years with the AGP of Rs.7000 shall be eligible, subject to other requirements laid down by the AICTE to move up to the AGP of Rs.8000.
- (10)Incumbent Lecturers (Selection Grade) who have completed 3 years in the Pre-revised pay scale of Rs.12000-18300 on 1.1.2006 shall be placed in the Pay Band of Rs.37400-67000 with AGP of Rs.9000 and shall be continued to be designated as lecturers (Selection Grade).
- (11) Incumbent Lecturers (Selection Grade) who had not completed 3 years in the Pre-revised pay scale of Rs.12000-18300 on 1.1.2006 shall be placed at the appropriate stage in the Pay Band of Rs.15600-39100 with AGP of Rs.8000 till they complete 3 years of service in the grade of Lecturer (Selection Grade), and thereafter shall be placed in the higher Pay Band of Rs.37400-67000 with AGP of Rs. 9000 and accordingly designated as lecturers (Selection Grade)
- (12) Lecturer (Selection Grade), completing 3 years of teaching with the AGP of Rs.8000 shall be eligible, subject to other conditions, as may be prescribed by AICTE, to move to the Pay Band of Rs.37400-67000 with AGP of Rs.9000.
- (13) Posts of HOD shall be in the Pay Band of Rs.37400-67000 with AGP of Rs.9000. Directly recruited HOD shall be placed in the Pay Band of Rs.37400-67000 with an AGP of Rs.9000, at the appropriate stage in the Pay Band in terms of the conditions of appointment.
- (14)Head of the Department (HOD), completing 3 years of service in the AGP of Rs.9000 and possessing a Ph.D. degree in the relevant discipline shall be eligible, subject to other conditions of academic performance as laid down by the AICTE, shall be placed in Rs.37400-67000 with AGP of Rs.10000.
- (15) For initial direct recruitment at the level of lecturers, HOD and Principal, the eligibility conditions in respect of academic and research requirements shall be as may be or have been prescribed by the AICTE, through Regulations.
- (16)All advancement to higher grade pays in various cadres will be effected subject to completion of two AICTE approved refresher programs of not less than two weeks duration each and two one week each TEQIP sponsored programs.

Lacies

(B) Workshop Superintendent:

Workshop Superintendent as treated at par with Lecturers and is to be considered for upward mobility similar to that of lecturers.

(C) Principals in Polytechnics:

Appointment to the posts of principal in Polytechnics shall be based on the conditions of eligibility in respect of educational qualifications and teaching/research experience laid down by AICTE from time to time, the posts of Principals shall be in the Pay Band of 37400-67000 with AGP of Rs.10000. All Principals in service shall be appropriately fixed in the pay band with the AGP of Rs.10000.

2. Increments:

- (i) Each annual increment shall be equivalent to 3% of the sum total of pay in the relevant pay band and the AGP as applicable for the stage in the pay band.
- (ii) The number of additional increment(s) on placement at each higher stage of AGP shall be as per the existing scheme of increment on promotion from lower pay scale to higher pay scale, however in view of the considerable raise in effective pay between the two pay bands, there shall be no additional increment on movement from the pay band of Rs.15600-39100 to the pay band of Rs.37400-67000.
