Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/Arrogant Restraint
- Undermining Human Dignity
- Financial Exploitation/Extortion
- Use Of Force

**A STUDENT INDULGING IN RAGGING CAN BE:**

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/part-time-leave, Scholarship/Fellowship and other benefits.
- Debarment from appearing in any test/examination or other evaluation process.
- Withholding results.
- Debarment from representing the institution in any national, national or international meet, tournament or youth festival etc.
- Collective punishment - when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.
